Bad Bridge Could Bring New Opportunities

The bridge across the **Clearfork River** that leads into **Y-Hollow** in **Eagan**, Tennessee, is known to the locals as the **dam of a bridge** because it is just that; a dam built in 1977. This bridge is the only way to safely get to the other side. **Marie Webster**, Director of **The Clearfork Community Institute**, a non-profit organization, which is located across the bridge, and serves residents of both **Campbell and Claiborne** Counties, stated," Last year a family had planned a Christmas party and due to heavy rains (a

flooded bridge) they had to walk across the railroad bridge with waters raging below." Pictured below is what the bridge looked like the last time it flooded which was March of this year.

This picture was taken before **Claiborne County Highway Department** pushed the cracks back together. The last inspection (2013) gave it a weight bearing capacity of 13 tons. Many residents doubt that it would support seven tons at present. It still has **no** weight limit sign posted. People ask, "Will it last through the winter?" "How will we get to the other side?" "Will we have to **try** to drive up and around the dangerous, steep, one lane, Eagan Mountain pass or walk across the trestle?"



The **Tennessee Department of**

Transportation (TDOT) gave the bridge a passing score in 2013 of 68.7. A second inspection was requested because the bridge received a higher score than the previous one despite nothing being done to improve the bridge between inspections. The second inspection gave it a sufficiency score of 54.6 and these were done before the March flood which almost washed it out. At present it's like riding a roller coaster across a cracked egg shell with the uncertainty that one will get to the other side. Certified letters were mailed to all the commissioners of Claiborne County and only two responded.

Bonnie Terry, a long time resident of Eagan (Rose's Creek area) raised an interesting question? **Do we really need a bridge or can an alternative be found**- one that is <u>less expensive</u>: <u>low maintenance with no major replacement costs?</u> The estimated replacement cost (2013) or the bridge from one source was \$350,000.00. Can the counties (both Claiborne and Campbell) afford not to talk with Bonnie and others that may have a better solution(s) than replacing the bridge?

New solutions could bring new opportunities for this small, rural, old mining camp that was built about 1900 by a financer from Atlanta, Georgia, by the last name- you guessed it-**Eagan**.

New solution(s) or vision (opportunities) that needs to be shared; one that would:

Increase property tax revenue for both counties.

Strengthen the local economy (some local jobs).

Invigorate the local community.

Make the community more livable/inviting for locals and businesses.

Include a comprehensive vision or plan that could be beneficial to the locals, the county and the state; a plan that could be used as a model for other communities.

Save the county and state about \$250,000.00.

Bring more tourism into the area.




Union and Clearfork Institute partner for Bonner Institute

Jodi Carroll, Director of Union College's Center for Civic Engagement and Marie Webster, Executive of Clearfork Community Institute, presented a workshop at the fall Bonner Directors and Coordinators Meeting & Assessment Institute. The Institute was hosted by the Corella & Bertram F. Bonner Foundation. The workshop was titled "Rural Disadvantage; Bonner Impact" and was inspired by the noticeable and disproportionate lack of resources for individuals living in extremely rural locations.





Union College and Clearfork Community Institute have partnered with the Bonner Foundation to develop programming in which Bonner students will address the socio-economic problems associated with rural America. Participants in the workshop represented colleges and universities across the United States at which Bonner students receive community service scholarships.

Participants contributed to the early discussion of ideas to increase high school graduation and college attendance among the children most disadvantaged by this phenomenon. Development is underway for a year round mentoring program that will include Union College Bonner Leader students. The program will also include other Bonner students from around the country.

Faculty from Union College, as well as other institutions, will have an opportunity to develop and oversee research and other academic work of students involved in this project. One of the first communities to receive this programming will be the Clearfork Valley of Tennessee which is near the birthplace of Mrs. Corella Bonner
